### **A. Scope of Work**

1. Conduct pre-audit of all payments prior to release of funds.
2. Verification of bills, vouchers, agreements, work orders, purchase orders, comparative statements, and supporting documents.
3. Ensure compliance with statutory requirements including GST, TDS, Income Tax and other applicable laws.
4. Scrutiny of contracts, vendor payments, reimbursements, advances, settlements, and financial approvals.
5. Verification of adherence to internal financial controls and accounting policies of HCA.
6. Submission of written pre-audit observations and certification before processing payments.
7. **Tender Support Work with Tender Committee**, including:
  - Verification of tender documents and financial bids.
  - Scrutiny of comparative statements and evaluation sheets.
  - Ensuring compliance with financial eligibility criteria.
  - Assisting in financial due diligence of bidders.
  - Certification of financial aspects prior to award of contracts.
8. Any other related financial scrutiny work assigned by HCA from time to time.

### **B. Experience**

- The firm must have a minimum of **5 years of experience** in conducting Internal Audit / Pre-Audit of Central/State Government Departments/ Autonomous Bodies/ PSUs/listed entities/ Sports Institutions/Sports Associations.
