## ORDER SCRUTINY OF NOMINATIONS

Scrutiny of nominations was taken up on 07.03.2026 (Saturday) at 11:00 am as per schedule. All the contesting candidates were informed of the scrutiny date and time along with the acknowledgement of receipt of nomination forms.

The meeting for scrutiny started at 11:00am on 07.03.2026. Only one contesting candidate Mr.K.Ganesh Pai was present. After allowing for 30 minutes time, the scrutiny of nominations was taken up one by one. No objections were raised for any of the nominations during the scrutiny.

After the completion of the scrutiny, when the process of preparation of list of valid nominations was on, a representation was received from Sri Chitti Sridhar of Acrylic Cricket Club. The representationist brought to notice that one of the contesting candidates, namely Sri Ajmal Asad figured in the list of names of officers (Office Bearers / Executive Committee Members) of one of the barred clubs in the order dated 31.07.2023 passed by Justice L.Nageswara Rao, Single Member Committee appointed by Hon'ble Supreme Court of India. A copy of the representation with the enclosures furnished by the objector are put on the website.

As the allegation in the representation is of a very grave nature, it is decided to continue the scrutiny enquiry for the next working day i.e., on 09.03.2026 (Monday) at 11:00am in respect of candidature of Sri Ajmal Asad, to afford an opportunity to both, for the objector and the contesting candidate to present their case before final decision is taken in the matter.

Accordingly, in order to take up examination of this specific case, the issue is posted for further hearing on 09.03.2026 (Monday) at 11:00am and after completion of scrutiny and passing of orders, valid list of nominations will be published.

Correspondingly, the date for withdrawal shall be on 10.03.2026 (Tuesday) from 11:00am to 4:00pm.


